1.0 Type of Personal Data Collected

- 1.1 It might be required to collect personal data from you during your dealings with the Group or for the purpose of related business activities.
- 1.2 Such personal data may include but is not limited to:
 - (a) name, job title and company name;
 - (b) age, gender, date of birth, identity card number, passport number, photograph, signature;
 - (c) race, ethnic origin, nationality, physical and mental health;
 - (d) contact information including address, email address and phone number;
 - (e) marital status, details of children, occupation, work history, performance reviews, income, employer, references and any other details of past employers;
 - (f) type of loans applied for in relation to purchase of property;
 - (g) financial and credit card details, bank name and other pertinent banking information, tax file identification number, EPF number, SOCSO number, criminal history; and
 - (h) such other data necessary for the purpose which the personal data is collected
- 1.3 We recognise that you may provide us with your Personal Data by completing our forms or by communicating with us in person or by phone, e-mail, fax, short message service, instant messages, written form or otherwise.

2.0 Consent

- 2.1 By providing your Personal Data to us, you have read and accepted the Notice, and you have consented to the processing of the Personal Data by us in the manner set out herein. Further, if you have provided the Personal Data of third parties to us, you warrant and represent to us that you have obtained the required consent of the third parties for the processing of the relevant Personal Data by us in the manner set out herein.
- 2.2 The Company may collect, use or disclose an individual's Personal Data without his / her consent in the following circumstances:
 - (a) the collection, use or disclosure is necessary to respond to an emergency that threatens the life, health or safety of the individual or another individual;
 - (b) the Personal Data is publicly available;
 - (c) the collection, use or disclosure is necessary for any purpose which is clearly in the interests of the individual, if consent for its collection, use or disclosure cannot be obtained in a timely way;



- (d) the collection, use or disclosure is necessary for any investigation or proceedings;
- (e) the collection, use or disclosure is necessary for evaluative purposes; and / or
- (f) in any other circumstances set out in the PDPA.

3.0 Purposes of Collection, Use and / or Disclosure of Personal Data

3.1 Examples of some situations where the Company collects, uses and / or discloses Personal Data, and the purposes of such are set out below.

- 3.2 The Group collects Personal Data primarily from the persons identified in the table set out above.
- 3.3 Unless permitted by laws, the collection, use and / or disclosure of Personal Data should be limited to that which is necessary for the identified purposes in the table above.

4.0 Disclosure of Personal Data

You hereby consent and authorize the Group to provide or disclose or share or reveal the Personal Data to the following classes of users:-

- (a) Related subsidiaries or associates or holdings companies, including future entities;
- (b) Government agencies, local authorities, utilities service providers, statutory authorities, enforcement agencies under the law and industry regulatory or other authorities if required or authorized to do so to discharge any regulatory function under any law or in relation to any order or judgment of court;
- (c) The Group's employees, auditors, consultants, accountants, lawyers, real estate agents, vendors, co-marketing partner, insurance company, property development and management manager and professional advisers;
- (d) The Group's contractors, subcontractors or third parties service or product providers as may be determined;
- (e) Financial institutions for purposes of facilitating payments and / or maintaining financial records in connection with the business or contract relationship between the Group and you and / or your company; and
- (f) Any other third parties the Group may deem necessary and expedient.



5.0 Withdrawal of Consent / Correction and Access to Personal Data

- As an individual, you may exercise your right to access the data held about you by this company by submitting your request in writing to the data controller.
- 5.2 Although all reasonable efforts will be made to keep your information updated, you are kindly requested to inform us of any change referring to the personal data held by the association.
- 5.3 In any case, if you consider that certain information about you is inaccurate, you may request rectification of such data.
- 5.4 You also have the right to request the blocking or erasure of data that has been processed unlawfully.

6.0 Retention Protection and Disposal of Personal Data

The PDPA regulates how Personal Data in the Company's possession is to be protected or dealt with. Some of the basic obligations and the corresponding required practices and policies of the Company are set out below and must be complied with at all times:

Action	Policies / Practices
Protection of Personal Data	The Company shall protect Personal Data in its possession or under its control against risk of unauthorised access, collection, use, disclosure, copying, modification or disposal through reasonable security measures.
Retention and Disposal of Personal Data	The Company must cease to retain documents containing Personal Data or remove the means by which the Personal Data can be associated with particular individuals as soon as it is reasonable to assume that: (i) the purpose for which the Personal Data was collected is no longer being served by the retention of such Personal Data; and (ii) retention is no longer necessary for legal or business purposes. In such event, the Company must ensure that the Personal Data is properly disposed of.
Transfer of Personal Data	The Company shall not transfer any Personal Data of an individual to a recipient outside Malaysia unless the standard of protection to Personal Data in the foreign country is comparable to the protection under the PDPA.

7.0 Transaction Security Policy
